### Factsheet on Rooftop Solar Development

- September 2020 -

#### 1. Background

On 05 July 2019, the Ministry of Industry and Trade (MOIT) issued [Decision 2023/QĐ-BCT](#) which launched the Rooftop Solar Promotion Program for the 2019-2025 period (RTS Programme) with the overall objective to promote the development of the market for rooftop solar technology. The program aims to install 100,000 Rooftop Solar (RTS) systems or the equivalent of 1,000 MWp by the end of 2025. Furthermore, the support of the rooftop solar market is one of the key policy targets and part of the [VEPG Policy Recommendations](#) that were endorsed at the 2<sup>nd</sup> High-Level Meeting of the VEPG in November 2018. With the aim to monitor the impact of the RTS Programme and the overall development of the rooftop solar market, Viet Nam Electricity (EVN) is providing data on RTS development in the country on a monthly basis.

Based on these monthly data reports by EVN, the VEPG will regularly update this factsheet on RTS solar development. This issue summarizes the EVN RTS data report for September 2020.\*

#### 2. Summary of RTS Development by the end of September 2020

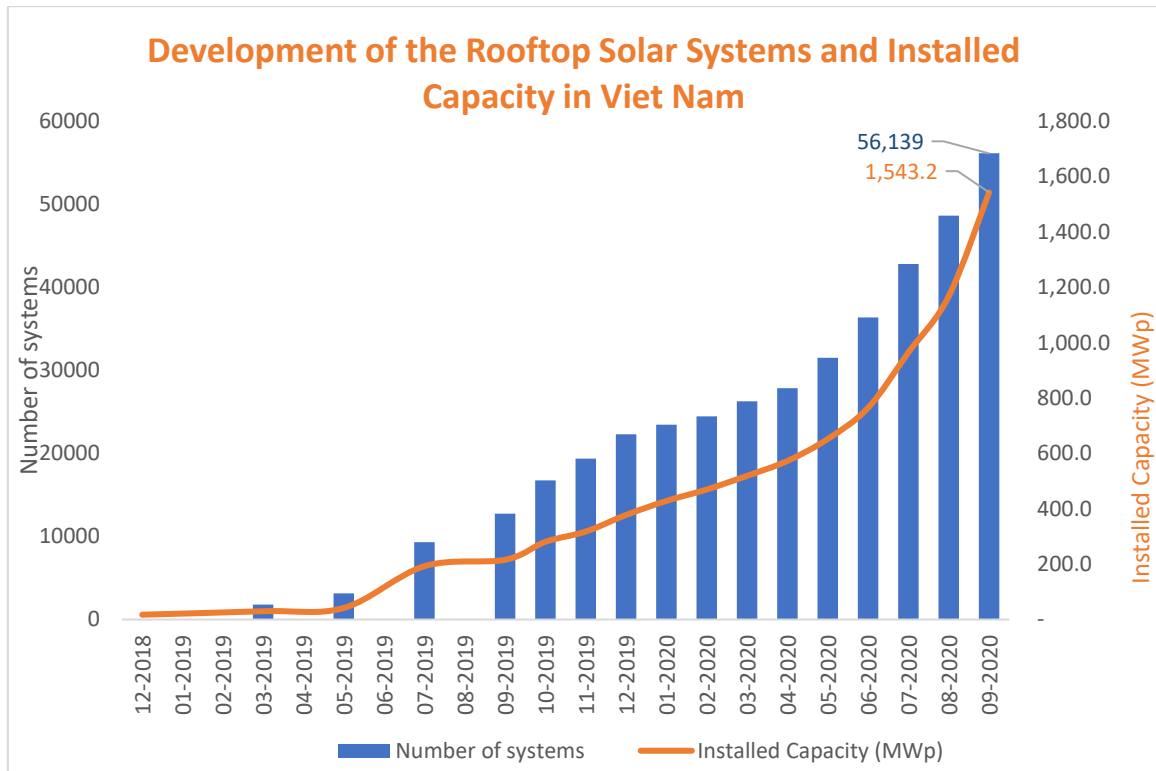


Figure 1. Total RTS systems and installed capacity (MWp) in Viet Nam by the end of September 2020

By the end of September 2020, a total of **56,139** rooftop solar systems (RTS) with a capacity of **1,543.2 MWp** were installed in Viet Nam (end of August 2020: **48,631** systems/**1,168.2** MWp). During September 2020, **7,508** rooftop solar systems with a capacity of **375.1 MWp** were newly installed (see Figure 1).

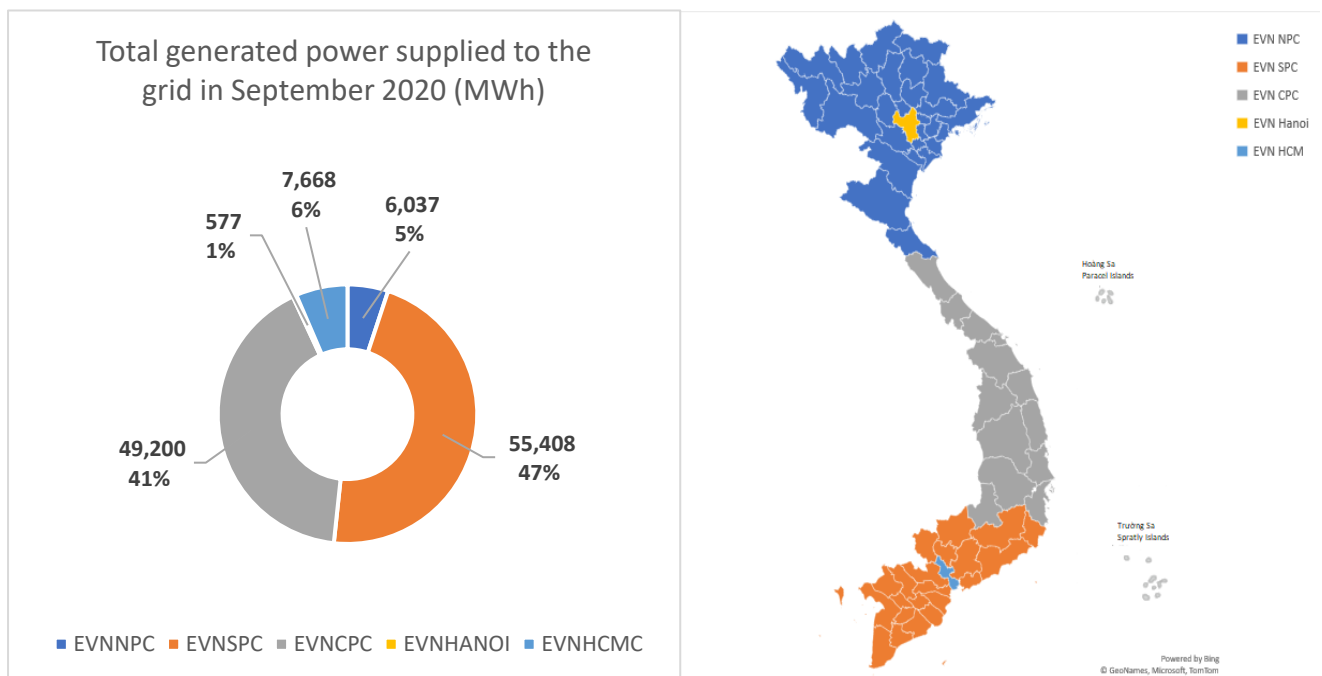


Figure 2. Total generated solar power supplied to the grid (MWh) by PC - September 2020

**Power supplied to the grid in September:** In September 2020, all installed rooftop solar systems delivered **118,891 MWh** (in August 2020: **82,671.4 MWh**) to the national power grid. **The Southern Power Companies (EVN SPC)** generated nearly half of the total solar energy supplied to the grid with **55,408 MWh** (Figure 2).

### 3. Geographical breakdown:

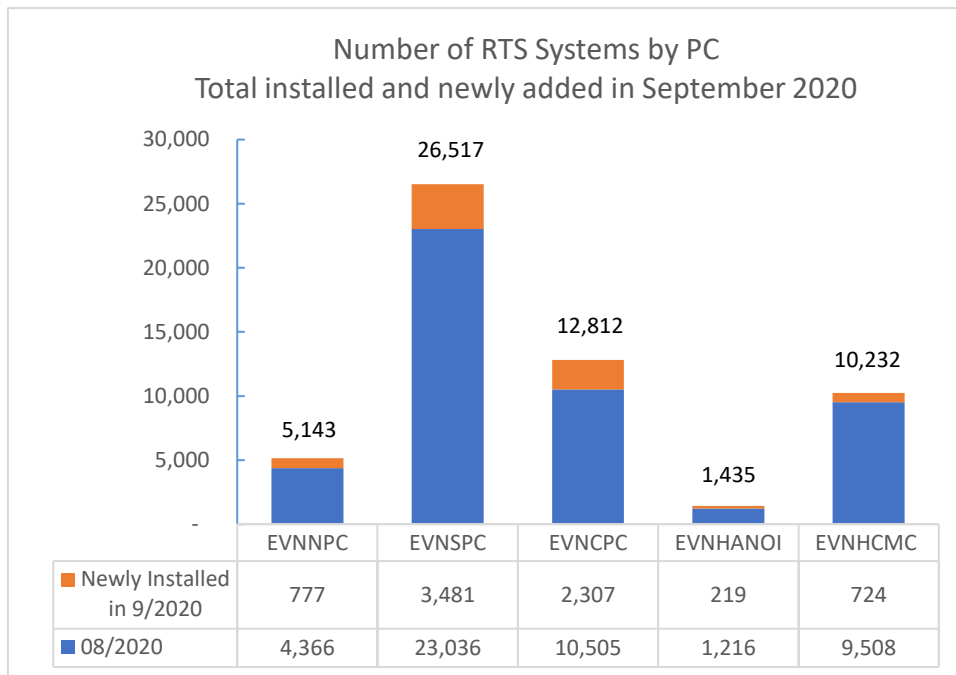


Figure 3. Number of RTS systems by PC – September 2020

**Number of installed systems:** In total, EVN SPC still have the highest number of RTS systems. EVN CPC has the second highest number of RTS systems. (Figure 3). In September 2020, **3,481 new systems** were newly installed under EVN SPC.

**Installed Capacity:** In September 2020, **177.41 MWp** were newly installed under EVN SPC and **157.68 MWp** was newly installed under EVN CPC. In total, EVN SPC and EVN CPC still have the highest installed capacity for Rooftop Solar in the country with **745.1 MWp** and **548.6 MWp** respectively.

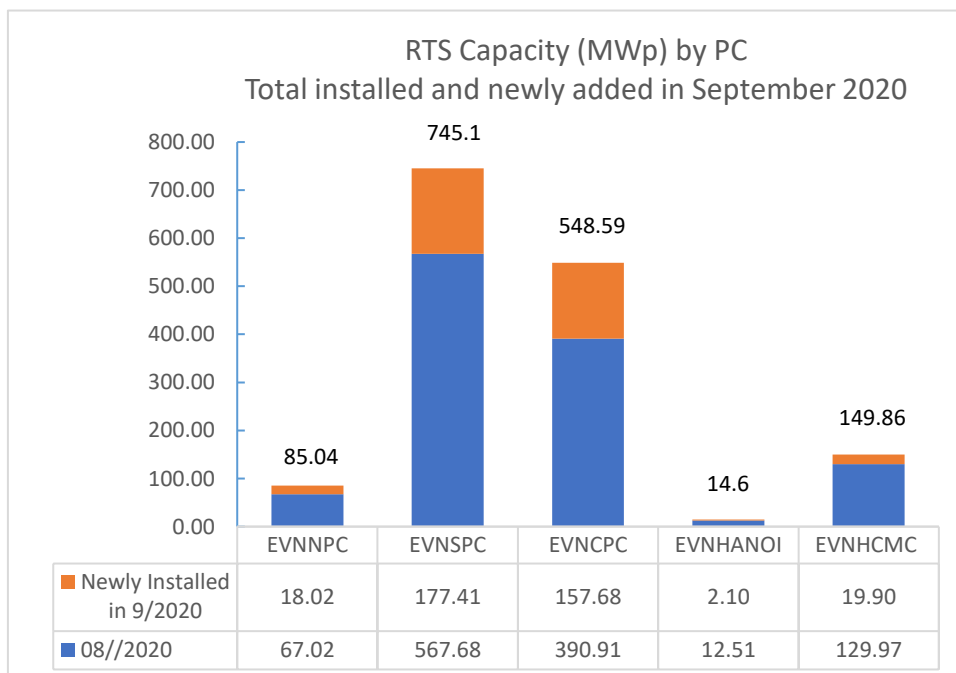


Figure 4. Installed RTS capacity (MWp) by PC - in September 2020

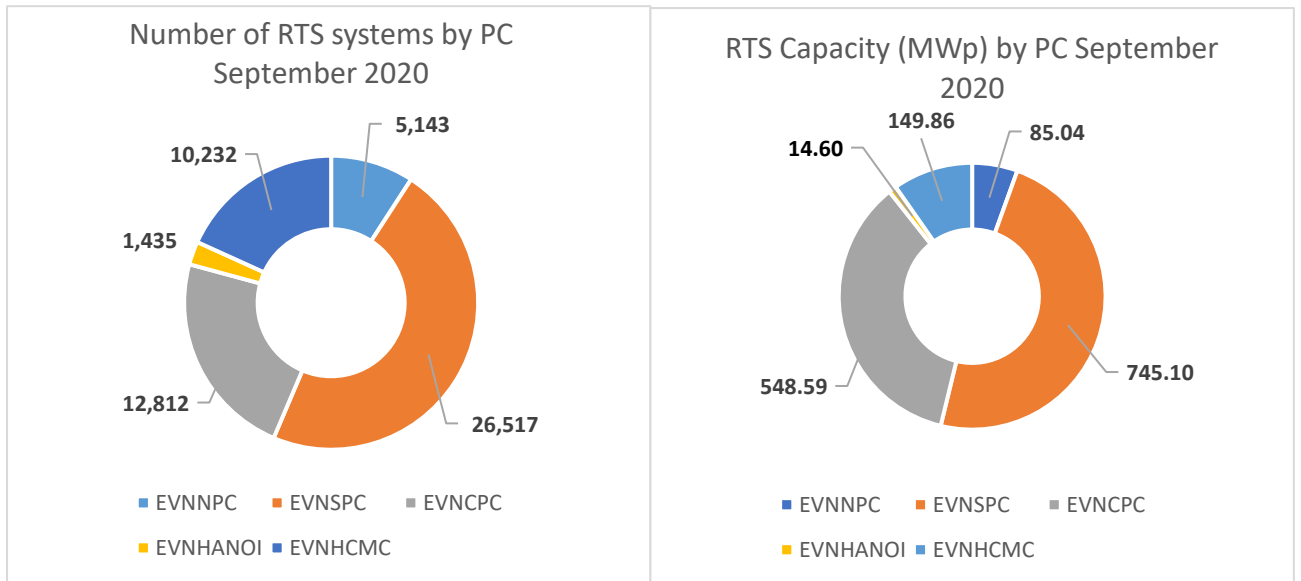


Figure 5. Break down of number of RTS systems and installed capacity by PC – September 2020

#### 4. Breakdown by Customer Group:

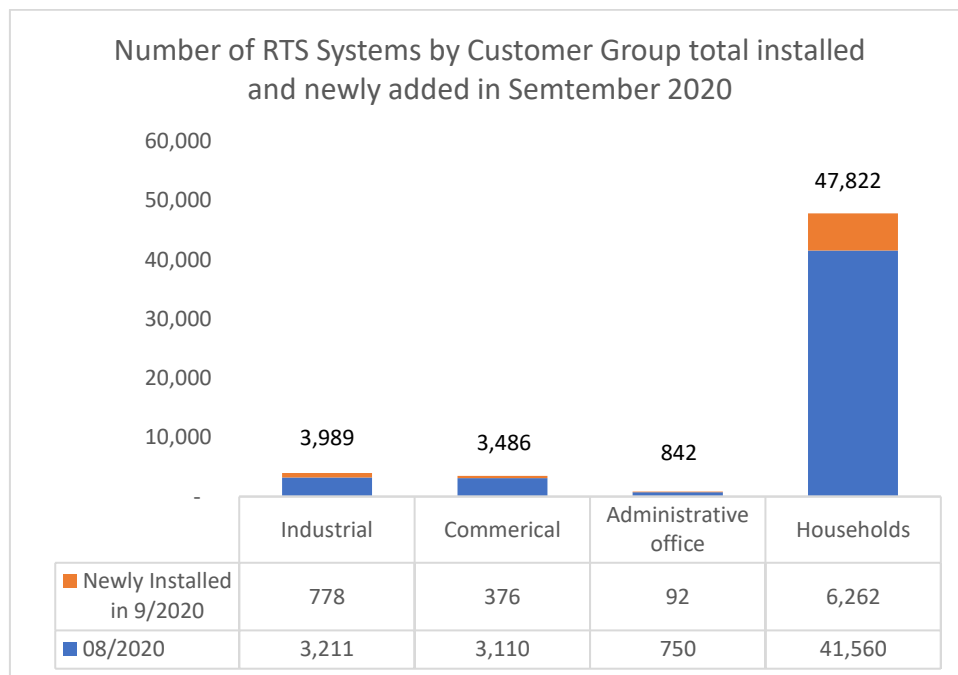


Figure 6. Number of RTS systems by customer group – September 2020

**Number of installed systems:** In September 2020, **6,262 household** systems, **778 industrial** systems, **376 commercial** and **92** systems on public buildings were newly installed (Figure 6).

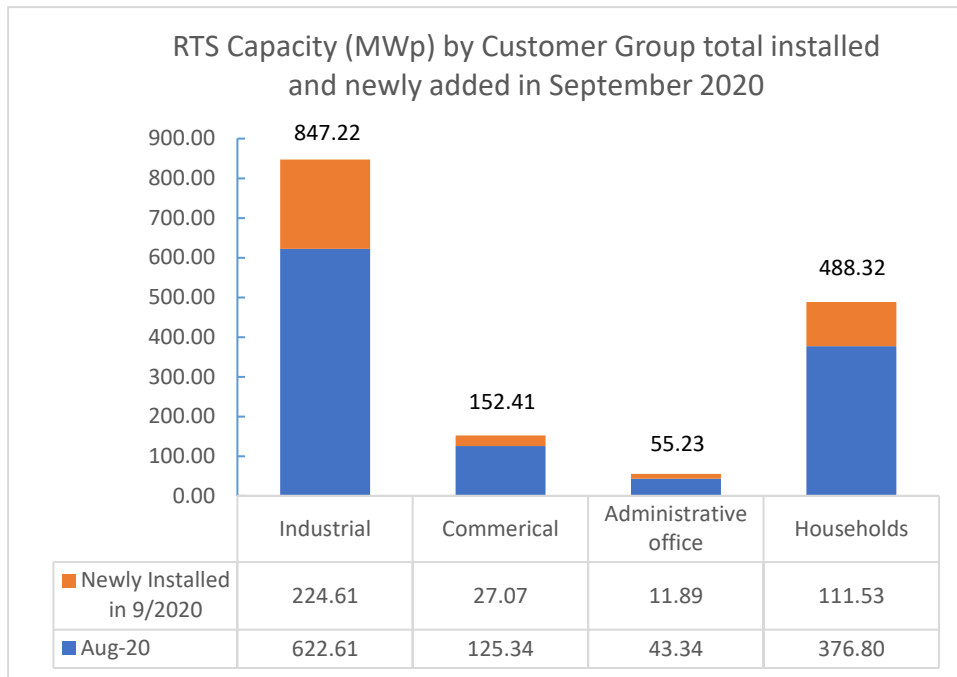


Figure 7. Total installed capacity by customer group (MWp) – September 2020

**Installed capacity:** In September 2020, newly installed **industrial RTS** accounted for **224,61 MWp** followed by **household RTS** with **111,53 MWp** and RTS for commercial and administrative building with **27.1 MWp** and **11.9 MWp**, respectively. (Figure 7).

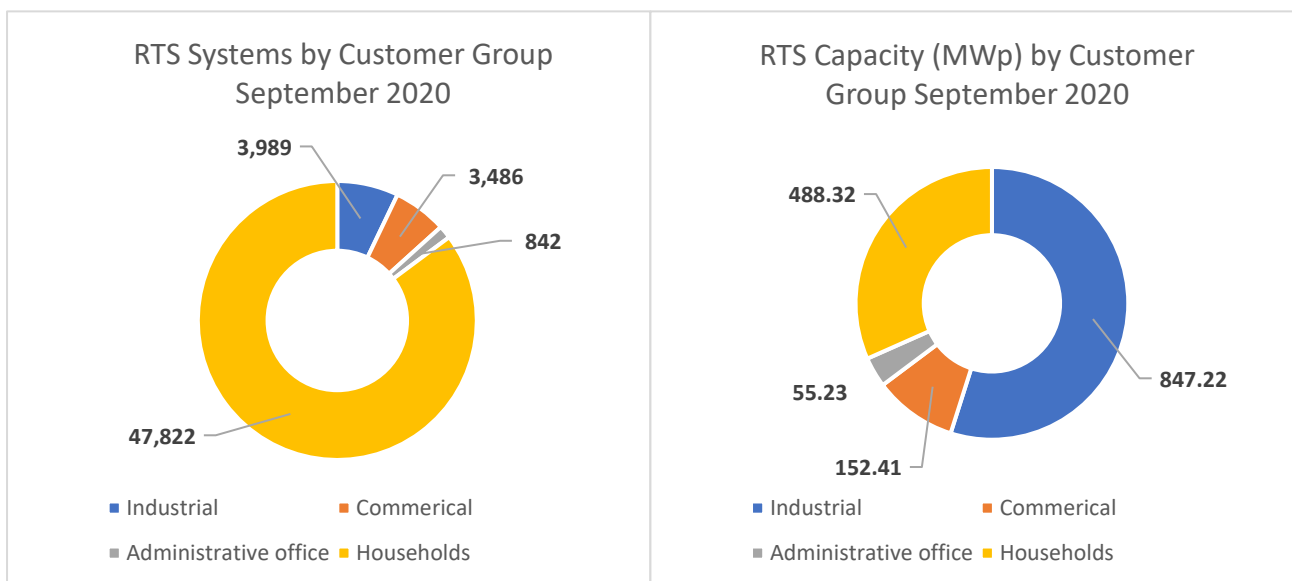


Figure 8. Breakdown of RTS systems and installed capacity by customer group – September 2020
