

Reduction of CO2eq:

- 1. Phase I: 24,179 biodigesters x 5 tones of $CO2/digester \times 15 years = 1,813,425 tones of$ CO2eq;
- 2. Phase II: 133,404 biodigesters x 5 tones of CO_2 /digester x 8 years = 5,336,160 tones of CO_2 eq;
- 3. Phase III: 23,000 biodigesters x 5 tones of CO_2 /digester x 1.5 years = 175,500 tones of CO_2 eq;
- 4. TOTAL: 7,325,085 tones of CO_2 eq.
