

**DECISION**

**ON APPROVAL OF ELECTRICITY GENERATION PRICE BRACKET OF WASTE-TO-  
ENERGY PLANTS IN 2025**

**THE MINISTER OF INDUSTRY AND TRADE**

*Pursuant to the Law on Electricity dated November 30, 2024;*

*Pursuant to Decree No. 40/2025/ND-CP dated February 26, 2025 of the Government on functions, responsibilities, jurisdiction and organizational structure of the Ministry of Industry and Trade;*

*Pursuant to Circular 09/2025/TT-BCT dated February 01, 2025 of Minister of Industry and Trade on application, procedures, and methods of determining and approving the electricity generation price bracket; regulations on application, procedures, and approval of the electricity import price bracket.*

*In consideration of proposals of the Vietnam Electricity in Documents No. 1771/EVN-TTD dated March 20, 2025 and No. 2516/EVN-TTD dated April 18, 2025;*

*At the request of the Director General of the Electricity Authority of Vietnam.*

**HEREBY DECIDES:**

**Article 1. Approval of electricity generation price bracket of waste-to-energy plants in 2025**

The maximum electricity generation price bracket in 2025 of waste-to-energy plants (solid waste) is 2.575,18 VND/kWh (VAT not included) in accordance with point a clause 2 Article 1 of Circular No. 09/2025/TT-BCT dated February 01, 2025 of the Minister of Finance on application, procedures, and methods of determining and approving the electricity generation price bracket; regulations on application, procedures, and approval of the electricity import price bracket

**Article 2. Implementation**

Based on the electricity generation price bracket of solid waste-to-energy plants prescribed in Article 1 of this Decision, Vietnam Electricity shall conclude the power purchase agreement with

the electricity generation unit in accordance with regulations on the method for determination of electricity generation price issued by the Minister of Industry and Trade.

### **Article 3. Implementation clause**

1. This Decision comes into force from the day on which it is signed.
2. The electricity generation price bracket of solid waste-to-energy plants in 2025 in this Decision shall be applied from the date on which the Decision No. 31/2014/QĐ-TTg in May 05, 2014 of the Prime Minister on policies for supporting projects generating electricity using solid waste in Vietnam ceases to be effective.
3. The Chief of Office, the Director General of the Electricity Authority of Vietnam, the Director General of Legal Affairs Department, the heads units of Ministries, the General Director of the Vietnam Electricity and relevant heads of electricity generation units are responsible to implement this Decision./.
